

2017 RICHMOND JUNIOR TENNIS CIRCUIT

The Richmond Junior Tennis Circuit (RJTC) is designed to make competitive play more accessible for our juniors. These tournaments are sanctioned L8 events and are for non-ranked juniors. These one-day tournaments will be held on Saturdays.

EVENTS

The singles events will be:

- Boys/Girls Co-Ed 8 and under**
- Boys/Girls Co-Ed 10s Orange Level 1**
- Boys & Girls 10s Orange Level 2**
- Boys & Girls 12s and 14s**

(Minimum of 4 players to hold an event. If a draw has less than 4, players may be moved or divisions may be combined to make a draw.) **Note: In keeping with USTA regulations, the 8 and under division will be played with the red ball on a 36 ft. court and modified scoring. The 10 and under division will be played with the orange balls on a 60 foot court. The 12 and under division will use the green dot ball on a full court.*

SCORING FORMAT

8 and under divisions will play 2 out of 3 seven point sets. All other divisions will play one set to 5 using no-add scoring with a 7 point tiebreaker at 4 all.

AGE ELIGIBILITY

The age division you play in is determined by the age you will be at the end of the month of any given tournament. Ex./ If the junior is 8 years old, but turns nine on June 28th, he/she must play in the 10 and under age division starting with tournaments June 3rd. Players having achieved a top 75 Mid Atlantic standing must play up an age division.
